## **Cheeky Monkeys at Durrell Tapestry Learning Journey**

The staff at Cheeky Monkeys at Durrell will have the opportunity to use Tapestry, an online programme designed to share photos, videos and observations of your child.

Tapestry is a UK based programme that is supported by a secure server. All information added to your child's online Learning Journey is encoded and the programme is constantly managed and monitored. It also has an anti-hack system to ensure all of the information is safe.

You will be able to use your own email address and a unique password to sign in to view your child's Learning Journey and comment on the observations we have shared. Tapestry also enables you as parents to upload photos of your child's experiences and successes at home.

The online learning Journey created through Tapestry is an excellent tool to use when sharing your child's achievements as it enables everyone caring for your child to stay up to date with his or her progress.

Please note that group photo's will often appear on each child's tapestry journal.

We would be grateful if you would sign to give permission to use this tool to create your child's online Learning Journey. After your child starts at CMAD, we will provide you with your unique password to access your child's personal Learning Journey.
